3.0 Intended use or uses of the construction product, in accordance with the applicable harmonised technical specification, as foreseen by the Manufacturer:

3.1 Intended Use – Pyroplex 200 and 400 series collars

The intended use of system 200 Series and 400 Series Collar System is to reinstate the fire resistance performance of rigid and flexible walls and floor constructions where penetrated by various combustible pipe services.

3.1.1 The specific elements of construction that the system Pyroplex 200 Series Collar System and 400 Series Collar System may be used to provide a penetration seal in, are as follows:

Rigid walls: The wall must have a minimum thickness of 150mm and comprise of concrete, aerated concrete or masonry, with a minimum density of 650 kg/m³.

Rigid walls: The wall must have a minimum thickness of 130mm and comprise of concrete, aerated concrete or masonry, with a minimum density of 650 kg/m³.

Rigid floors: The floor must have a minimum thickness of 150mm and comprise of aerated concrete or concrete with a minimum density of 650 kg/m³.

Flexible Walls: The wall must have a minimum thickness of 130mm and comprise either or timber or steel studs lined on both faces with a minimum 2 layers of 15mm Type F Gypsum boards according to EN520. In timber stud walls, no part of the penetration shall be closer than 100mm to a stud, and minimum of 100mm of insulation compliant with Class A1 or A2 according to EN13501-1, shall be provided within the cavity between the penetration and the stud.

The supporting construction must be classified in accordance with EN 13501-2 for the required fire resistance period.

3.1.2 200 Series Collar System and 400 Series Collar System may be used to provide a penetration seal with specific combustible pipes, single only.

3.1.3 Apertures in the separating element shall be maximum 5mm diameter oversize with respect to the pipe diameter. The remaining annular space/gap shall be infilled with Pyroplex Intumescent Acrylic Sealant used for the purposes of smoke sealing. Apertures provided within the supporting construction shall be separated by min. 200mm.

3.1.4 Pipes shall be supported at a maximum 320mm away from both sides of the wall constructions and from the upper face of floor constructions.

3.1.5 European technical approval ETA 15/0136.

3.1.6 The product must be installed in accordance with the Pyroplex Technical Data Sheet.


